WHO SHOULD ATTEND THE 53rd ANNUAL OPERATORS' CONFERENCE?

This is a "must attend" event for individuals requiring up-to-date, hands-on information for the operation of drinking water treatment, distribution, wastewater collection and treatment systems. The Annual Water and Wastewater Operators' Conference will provide access to over 70 technical sessions and over 100 exhibitors as well as an opportunity to network and exchange information with fellow professionals. Operators can earn a maximum of 18 continuing education hours by attending each six-hour day of classes. Conference training will be submitted to the Kentucky Boards of Certification of Water Treatment, Distribution and Wastewater System Operators for approval toward license renewal. Training hour documentation will be provided to the Division of Compliance Assistance as verification of hours earned.

HOW DO I REGISTER TO ATTEND THE CONFERENCE?

If completing the registration form on the following page, be sure to include payment with the form. If registering online, you may pay with credit card, bank draft, debit card, etc. utilizing Pay Pal. Simply follow the instructions.
