We all like to feel as if the ground under our feet is firm and not shifting. I know last year with all the pension talk, it was hard to feel that way whether you are a retiree or someone who is still working within the covered retirement systems. Now with the SB 151, the "sewer bill", struck down as unconstitutional for how it was enacted, a failed special session and the Legislature back in session in January, the focus will once again be on pension reform. Let's hope that this time, they follow procedure and work across the aisle to fix what needs to be fixed and leave the rest alone.

Added to this uncertainty is the fact that the Department of Environmental Protection (DEP) is contemplating changes to the operator certification regulations as well. KWWOA has been monitoring the potential for changes over the past year and a half, given the Division of Water's inclusion of this topic on their Drinking Water and Wastewater Advisory Board agendas, as well as the outcry by large public water systems over their inability to advertise and hire certified operators as baby boomers age out and retire. KWWOA found this approach a bit unusual given that the Kentucky Boards of Certification, as established by KRS 223.170 and 224.73-110, have traditionally served as the primary advisors to DEP on operator certification and system staffing. The only assumption which could be garnered was that some systems and industry related groups were waving this flag of concern with DOW in hopes that it would gain greater momentum than if concerns were brought to the attention of the Kentucky Boards of Certification and the Division of Compliance Assistance.

The current operator qualifications and drinking water plant staffing requirements have essentially been in place since November of 1990 or almost 30 years. The questions are whether the operator qualifications and/or drinking water plant staffing requirements are overly stringent for the preservation of human health and the environment or is it that Systems are not property planning for their staffing needs and/or not paying a comparable wage? If the requirements are too stringent, then they should be revised. If systems are not planning for their staffing needs and/or not offering a comparable wage, then changes to the regulations will more than likely be of no help. This is also true if retirement benefits are further reduced, as there will no incentive to work shift work, much of it outside, in a low paying, highly responsible job.

Every one knows that the greatest number of our workers fall within the "Baby Boom" generation which is defined as people born from 1945 to 1964. Given that this places those people between the ages of 54 to 73, it is obvious that these individuals are either thinking about retirement or are retired. To encourage proper planning, DCA has been making presentations over the past few years to reinforce this point and encourage systems to "grow" their own operators. And while some, have hired trainees, others have elected to wait till the situation is upon them and then advertise for a properly certified operator. While that might be a option for some systems, most will not secure an operator this way due to the salaries paid across the state, the benefits offered and the fact that shift work is a given. If

the System is close to the Kentucky border, they also have to compete with the surrounding states, as only one pays operators less than Kentucky.

In mid-December, KWWOA was provided with the draft changes being proposed to 401 KAR 8:050, 11:030, 11:040, 11:050 and 11:060 and asked to provide comments, along with multiple industry groups, engineering firms, and water and wastewater systems. Potential changes had been discussed with the Certification Boards, but they received the draft regs at the same time as the regulated community and new initiatives were included that had not been discussed. Comments were to be submitted by December 20th, as the intent is to file the regulatory changes with the Legislative Research Commission in January 2019. During a joint meeting of the KY Boards of Certification of Drinking Water Treatment and Distribution and Wastewater System Operators on December 18th, the changes were discussed in general and several issues of concern were brought to the attention of Peter Goodmann, Director of the Division of Water & Amanda LaFevere, Director of the Division of Compliance Assistance. We were told that no changes were being contemplated to 401 KAR 8:030 which contains the staffing requirements for drinking water systems. A commitment was made to meet with the Certification Boards in early January, as this was their first opportunity to see the regulatory language proposed and there were several fundamental concerns voiced by this group during this meeting.

Outlined below are some of the issues that KWWOA considers to be of greatest concern:

- 401 KAR 11:030—Reduction of the experience requirements for a Class III and IV wastewater treatment operators. While KWWOA feels that the experience requirements for a Class IV may be considered for a slight reduction, the Class III should remain the same. No basis was given for the reductions by DCA nor DOW.
- 2. 401 KAR 11:040—New language that was added for clarification purposes, relative to drinking water plant coverage by classification, causing conflict with the 401 KAR 8:030 staffing requirements. This needs to be fixed to prevent confusion.
- 3. 401 KAR 11:030 and 040—Substitutions of education that could ultimately result in the experience requirements being reduced to six months for a Class IV license. KWWOA is against any substitution that reduces the requirements for a Class II—IV operator being less than one year.
- 4. The regulation at some point removed the requirement for "Limited Certificate" applicants to have a high school diploma or GED. KWWOA believes all operators should have a high school diploma or GED, especially those operating a school system drinking water plant.
- 5. The regulations currently provide for the issuance of "Operator in Training" (OIT) certificates. Language was added in an attempt to clarify this process, but it is still unclear. KWWOA also maintains that OITs are not fully certified as they have not met all the requirements for certification.

Potential benefits within these draft regulations include:

- 1. Expansion of the degrees allowable for consideration either as education or as a substitution and the addition of how these courses are to be counted when no degree is awarded.
- 2. Recognition and quantification of other types of experience, such a lab experience.
- 3. No changes to the drinking water treatment plant staff requirements were made within 401 KAR 8:030.

Peter Goodmann acknowledged during the meeting that facilities soliciting an Alternative Staffing Plan, should be requesting such due to unforeseen circumstances, such as an employee who is diagnosed with a debilitating disease. It is not to be routinely used, as a mechanism for meeting the staffing requirements. Approved Plans will be incorporated into an agreed order with stipulated penalties.

A joint meeting is to be scheduled to do a line-by-line regulation review with the Certification Boards in early January. How this review will ultimately impact the draft language and/or DEP's submittal of the regulations to LRC in January, is yet to be seen. Until then, we will remain vigilant in our reviews and submit comments where possible. We have posted the draft regulations on the "Resources" tab of our website (www.kwwoa.org) for your review. Any comments you have can be added to the regulations in another color than black and forwarded to KWWOA at info@kwwoa.org. Given the timeline originally quoted, this needs to be done quickly. Any additional reg changes will be posted on the website & KWWOA members notified.

As referenced, the Central Chapter also handed out plant and operator awards during this event. Outlined below are the winners within each category which will now be considered for a state wide award.

The Wastewater Operator award was presented to Kenneth Horn, Ft Knox Wastewater System Supervisor and Class IV Wastewater Treatment and a Class IV Collections Operator. He oversees the 24-hour/day operation of the Ft Knox WWTP, is heavily involved in collection system activities, as well as the Safety Committee. He and his staff have led Confined Space Training and he has been integral in putting together monthly safety training for all the District's facilities. He has trained several of the operators at the Ft Knox and Radcliff WWTPs. He is very mechanically inclined and has been involved with rehabbing lift stations in the Ft Knox and Radcliff collection systems and has led the rebuilding of clarifier gear boxes at Radcliff WWTP and the Pirtle Spring WTP. He is a team player and is always willing to help with any task.

Kenneth also accepted the award for Outstanding Wastewater Treatment Plant of the Year which went to Fort Knox Wastewater Treatment Plant. The Fort Knox Plant was built in 1995 and treats all municipal waste (including all latrine and grey water waste) from the not only the Army Base but the City of Muldraugh.

This facility has been owned by the Hardin County Water District No. 1 since 2005 and consists of a 6 mgd extended aeration plant, with four Secondary Clarifiers, UV Disinfection, Aerobic Digestion, and two 2 cubic meter belt presses. The average daily flow is 1.7 mgd. and they have processed 933 tons of bio-solids (YTD). Their Collection System consists of 38 Lift Stations. The system is staffed 24/7 by six operators.

The Drinking Water Operator Award was presented to Christopher Gohman who holds Class IV Water Treatment and Distribution Certifications. Chris has a B.S. in Chemistry from Georgetown and is the Supervisor at the Pirtle Spring WTP, which is a 3.1 MGD facility that operates 24 hours/day.

He is an exceptional young man, not only in his education and athletic background, but also in his humble yet can-do attitude. He has been with the District for a relatively short time, but has quickly climbed the ranks from Operator-Trainee, to Water Quality/Measurement Specialist, to WTP Supervisor. He has earned the trust of administration, the WTP staff, the staff of the other District utilities, and outside utilities. He is a team player and is willing to help out in any way that he or his staff is able.

He has worked diligently to prepare himself and the staff for the District conversion to chloramines and because of this, the transition was a smooth one. He is responsible for changing

the ammonia gas feed to LAS, a much safer chemical for his operators. Christopher can be commended for always looking for better ways to do things! Through networking with other utilities, he has also begun to research the chlorine feed system and will possibly change to a safer chemical and eliminate another.

### KWWOA Vice-Chairman Wanted!

KWWOA's bylaws call for its membership to elect a Vice-Chairman for the State Board who will serve for two years and then transition into the position of Chairman. Robin Strader's term will come to a close during the 62nd Annual KWWOA Conference in April and Donald Compton will begin his two-year term as Chairman. As a result, we need to back fill the Vice-Chairman's position.

KWWOA is currently soliciting nominees to run for the position of Vice-Chairman in an election that will be held just prior to the Conference (Ballots should be received in early March). At the present, we have one candidate, Jeremy Woosley, Grayson County Water District, who has declared his intent to run for this position. The duties of the Vice-Chairman include:

- It is the responsibility of the State Vice-Chairman to help guide the Association based on its Mission Statement and Objectives set out in the Bylaws and any other strategic plans developed by the State Board.
- Conduct, in the absence of the Chairman, a minimum of one business meeting per year of all the members of the Association at a time and place selected by the Board of Directors. Conduct, in the absence of the Chairman, a minimum of four meetings per year of the State Board of Directors. As a proxy, the Vice Chairman will only vote on KWWOA State Board affairs in the event of a tie.
- Assist in promoting KWWOA's standard operating procedures among the State and Chapter Officers to ensure that all are actively/properly performing their duties.
- Work to ensure that all KWWOA training programs are approved by the KY Boards of Certification and records are maintained for such in the proper manner.
- Work with the State Board and Chapter Officers to promote KWWOA Membership, training and events to all certified operators, drinking water and wastewater systems, sub-organizations, and associates involved in the business.
- Work to ensure that Association funds are properly safeguarded and documented and that expenses are paid within 30 days. Ensure that financial reports are submitted to all the proper authorities (State Board, KY Secretary of State, IRS) in a timely manner.
- Assist with locating advertisers for the KWWOA newsletter, web page, events and Annual Conference.
- In the long-term absence of the Chairman, serve as the primary supervisor to the Member Services Director, contract State Treasurer and other employees and Sub Organizations, who may be hired, performing all necessary duties to ensure the success of these employees. The Vice-Chairman shall serve as Chair of the Awards Committee and ensure that the Awards SOP is followed in the awarding all State Level Awards.

### **Ensuring Access to Potable Water**

Recently, the Herald Leader ran a three part series, entitled "Stirring the Waters" which talked about the challenges being encountered in Eastern Kentucky, with having access to clean, reliable and affordable drinking water. While the focus was on Eastern Kentucky, we are all facing a crisis in this country as it relates to aging infrastructure, both above and below ground. In part three of the series, Will Wright included a companion article that talked about five ideas that could make it easier to ensure reliable access to potable water. As drinking water operators, you are well aware of these ideas, but it reiterated for me the need to reinforce this message with our customers and community in general. Operators are somewhat like our water infrastructure, out of sight out of mind, but being a part of the group to shape and share this message helps all involved!

Within this article, Mr. Wright produced several ideas for making potable water more accessible. While some may appear obvious, they are worth talking about in every community. The first is the need for **more grants to fund service line repairs**. Grant money has been available in the past to build newer, bigger, better plants, but traditionally has not been there for service line repairs. Billions of dollars are sitting in federal Abandoned Mine Land funds and some have even been allocated for economic-development in the coal regions, but a decision has already been made that these funds cannot be used to replace nor repair service lines. While repairs may or may not lead to new economic development ventures, we could all argue that our existing businesses and industry need a reliable water source to maintain their services and without it, they will go elsewhere. Perhaps we need to contact our U.S. Senators and Representatives and float this idea, given the current focus at the national level on infrastructure needs.

We also have an obligation as utilities to make sure that our rates are reflective of the true cost to produce and distribute water. If not, we need to educate our governing boards and the public on the need to **raise rates** or risk falling behind in the services we provide. That responsibility falls on the backs of operators and managers within the Utility. Without an effort to communicate and educate the community, how can you expect them to fully support system improvements. If we cannot justify the need, who can? Also, as stewards of the community, we also have an obligation to look to the future and help our communities put in place a plan to address their infrastructure needs. If we aren't paying the true price of the water today, how is that going to help them in the future.

All utilities should have to develop a **multi-year plan that examines the needs of the district and sets out how they are going to fund and implement those needs.** It all goes back to the need to educate the public during plan development to garner support and then constant reporting on plan implementation. Also, when someone wants you to deviate and/or use valuable resources in another manner, you have a guide to use as justification. As they say, how do you eat an elephant? One bite at a time. While the work may seem insurmountable, you have to stick with the plan each day and simply take one bite of it at a time.


### KWWOA Needs Your Help!

We are making efforts to solve the issue but we still need your help. If you receive a suspicious email that contains Lisa's name and email, we would appreciate you sending us the email header information from it. This header contains critical information identifying the originating sender; with this information we can report the IP address and email address to the email provider to have it blocked. Outlined below are step-by-step instructions for retrieving the header from Outlook or Google mail:

If you utilize **Outlook,** double click the suspicious email in your Inbox to pop out from Outlook. Don't worry this will not open any attachments:



Some people also advocate that **regulators need more authority** when it comes to systems who repeatedly fail their customers. Set out as an example is Martin County Water District (which I am sure they are tired of!). If governing bodies fail to consistently increase rates to meet their needs, ignore suggestions to make necessary repairs and fail to plan for or address service outages, the state should be able to step in and impose a new management team, as their customers are being help captive and need assistance.

While running the risk of sounding like a broken record, **you have to engage the community** in all you do. It may seem boring and mundane to you, but if you constantly share information with the public via the local newspaper, social media, encouraging them to board meetings, they not only have some concept of what you do but begin to trust that you are working with their best interest in mind.

While I hate to admit it, operators may be no better off today than 30 years ago, as it relates to the public knowing the quality, life changing services you provide to them on a daily basis. Unfortunately, this may spill over to your employers as well. This goes back to operators, as individuals, needing to be knowledgeable about their business and talk it up to everyone that will listen. Utilize every opportunity you have to tell the public about the work you do and identify for your employers, issues that you see. People aren't mind readers and if you don't speak up, how can they know the true "needs" of the system.
